

## PRIVACY POLICY

www.seatgate.info knows that you care how information about you is used and shared, and we appreciate your trust that we will do so carefully and sensibly. This notice describes our Privacy Policy. **By visiting [www.seatgate.info](http://www.seatgate.info), you are accepting the practices described in this Privacy Policy.**

### 1. COLLECTION OF INFORMATION

*Purpose.* The information we learn from customers allows us to personalize and continually improve the total online experience at [www.seatgate.info](http://www.seatgate.info). Here are the types of information we gather:

*Contact information.* We might collect your name and email address. We might also collect your contact telephone number or physical address.

*Payment and billing information.* We might collect your credit or debit card information.

*Miscellaneous information.* We might collect your age or gender. We might also collect information about events you like.

### 2. SHARING OF INFORMATION

*General.* The information that we collect about our customers is critical to our business. We respect and value this information, and do not want to jeopardize the flow of information between our customers and the site. Therefore, we are not in the business of selling this information to other Web sites or businesses. There are very limited circumstances where we do share some customer information, and this is outlined immediately below. ### 3. INFORMATION SECURITY

*Software Used.* To protect the security of your information during transmission, we use Secure Sockets Layer (SSL) software, which encrypts information you input.

*Order Confirmation.* We reveal only the last five digits of your credit card numbers when confirming an order. To process an order, it is necessary to transmit the entire credit card number to the appropriate credit card company.

*Signing off.* To prevent unauthorized access to sensitive information, it is important for you to monitor those who have access to your password and to your computer. Be sure to sign off when finished using a shared computer. Visit our Web site for more information on how to sign off.

#### **4. USER ACCESS TO INFORMATION**

*General.* When you access your account, there is a variety of information that you will see. This is designed to allow you to update any changed information and view the information that you entered previously. This information is sensitive, and it is necessary to both protect this information and keep it current in order to have the best experience at our site. Examples of the type of information that can be accessed by signing into your account are on the Web site.

#### **5. USER CHOICES WITH REGARD TO ACCESS OF INFORMATION**

*Prior Information.* You can add or update certain information.

(You cannot waive the applicability of the Conditions of Use and other legal notices, such as this Privacy Policy, and if you elect not to receive those notices, they will still govern your use of [www.eagate.info](http://www.eagate.info), and it is your responsibility to review them for changes.)

#### **6. CHILDREN**

## **9. AUTOMATIC INFORMATION**

As discussed earlier, our systems collect information that is sent over the internet without your control.

*Examples.* Some examples of the information we collect and analyze include the Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information such as browser type and version, operating system, and platform; purchase history, which we sometimes aggregate with similar information from other customers to create features such as bestsellers and product suggestions; the full Uniform Resource Locator (URL) clickstream to, through, and from our Web site, including date and time; cookie number.

*Software Used.* During some visits we may use software tools such as JavaScript to measure and collect session information, including page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page.
